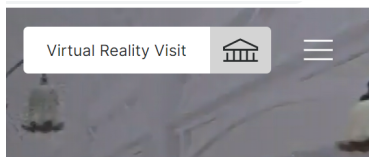


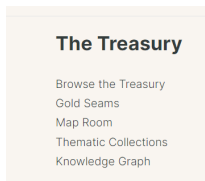
Using the VRTI: www.virtualtreasury.ie

BROWSE

1: On the Virtual Treasury homepage see the **Menu** icon in the top right corner



2: Go to **The Treasury** stack and select **Browse the Treasury**



3: Scroll down the list to the repository you wish to view.

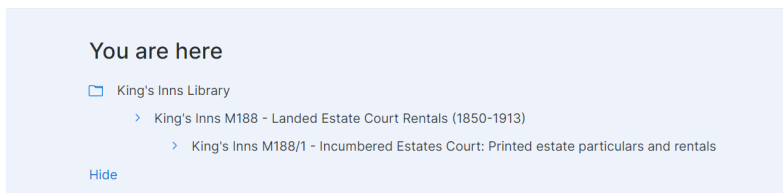


Click the arrow to unfold the contents, click subsequent arrows to view the lower layers.

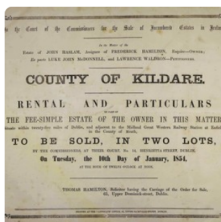


The image icon shows that images + metadata are available. A greyed-out image icon means that metadata only is available.
Note: images may be available at lower hierarchical layers.

4: The archival hierarchy appears on each search result, showing where the items sits within the repository's collections.
